

## Sessional Doctor (Self-Employed)

### About HealthLink360

Founded as a Charity in 1983, HealthLink360 [SCO 00948] is Scotland's leading provider of medical, psychological and travel health support to mission and aid agency workers, medical relief teams and volunteers who undertake overseas work in challenging and often hostile environments; as well as those who work within the UK. Embracing our ethos of 'whole person care for global workers' HealthLink360 provides a unique service offering a comprehensive range of medical, psychological and travel health services both in person, at our Travel Clinic just outside Edinburgh, and – where possible - online.

HealthLink360 was born out of the personal experiences of its founders, the experience of those who travel internationally to work, often in intense and high-risk environments, only to return home physically or mentally fragile. We provide an expert level of care to our clients before they go, during their assignment and when they return. Our clients consist of mission and humanitarian organisations and their personnel, GAP year organisations, those in church leadership, families, young adults and members of the general public. We work with those from faith backgrounds and those of no particular faith.

### About the role

Our experienced team (a mix of contracted and self-employed/sessional) includes doctors, travel nurses, clinical psychologists, counsellors and operational staff. Our clinic, where this role would be based, is located at Carberry near Edinburgh and is currently open 3 days per week (Tuesday, Wednesday and Friday).

We are looking to recruit additional flexible sessional capacity into our team of experienced doctors. The post holder will join our team offering medical assessment, health screening and health advice for HealthLink360 clients, who may be adults, young people, or children.

In view of the variable demand for our services, no set hours are confirmed for this role but work will be as is available and agreed. We envisage that initially this may potentially be up to 2 sessions per month, on average but is dependant on available work.

As well as having a GMC registration and bringing post-graduate experience and additional post-graduate training, we are particularly looking for candidates with a background in Occupational Health who have completed an Occupational Health qualification such as DOccMed or MFOM. We ask that the post holder work in sympathy with HealthLink360's Christian ethos and in view of the nature of our work, experience of living or working overseas is desirable. Candidates will hold their own professional indemnity insurance and cover for telemedicine would be an advantage.

We offer a friendly working environment, a competitive level of pay and hope that a candidate will be available to start as soon as possible.
